

**MINUTES OF THE 27th MEETING OF THE STEERING COMMITTEE ON
INTEGRATED WATERSHED MANAGEMENT PROGRAMME HELD ON 31.07.2012
AT NIRMAN BHAVAN, DEPARTMENT OF LAND RESOURCES, NEW DELHI**

The 27th meeting of the Steering Committee on Integrated Watershed Management Programme (IWMP) was held on 31.07.2012 under the chairpersonship of Secretary (LR) in the Committee Room of Department of Land Resources at NBO Building, Nirman Bhavan, New Delhi. The list of participants is at **Annexure-I**.

2. The Secretary welcomed the participants to the first meeting of the Steering Committee during the year. She reviewed the progress of implementation of IWMP in the States of Andhra Pradesh, Gujarat, Jharkhand, Meghalaya and Tamil Nadu. She informed the participants regarding changed procedure for fund release under IWMP and guidelines issued for Evaluation of Preparatory phase of IWMP projects. She also mentioned that as per the operational guidelines of institutional funds, the Department has initiated a study to review & evaluate the performance of SLNAs to see if the creation of institutional structures dedicated to watershed programmes has achieved the purpose for which they have been created. She further informed that a Committee has been constituted to revisit the Common Guidelines for Watershed Development Projects. She asked the representatives of the State Governments to send their comments on the provisions of the guidelines requiring amendment. She stressed on expediting the pace of expenditure and on timely submission of the Utilisation Certificates.

3. ANDHRA PRADESH:

The Special Commissioner (Watershed) Andhra Pradesh made the presentation on performance of the 454 IWMP projects sanctioned to State during 2009-10, 2010-11 & 2011-12 covering 19.62 lakh ha in 12 districts. The State has been allocated a minimum tentative area of 4.06 lakh ha for 2012-13.

(i) Regarding the progress of ongoing Hariyali projects, the Special Commissioner stated that no further funds would be required as the balance works of ongoing IWDP & DPAP projects would be completed through MGNREGS. The State representative assured to submit the pending UCs for an amount of Rs 40.18 crore by September 2012. She also assured to submit the requisite documents for the 23 non performing projects identified for foreclosure by September 2012.

(ii) The progress of engagement of experts & staff in the dedicated institutions at different levels, was found to be satisfactory.

(iii) The State representative informed the Committee that DPRs for the 110 projects sanctioned during 2009-10 and 171 projects sanctioned during 2010-11 have been prepared. However, for projects sanctioned during 2011-12 only 40 DPRs out of 173 have been prepared and remaining will be completed by August 2012. The 110 DPRs for the projects sanctioned during 2009-10 have been uploaded in the website. However, for 2010-11 projects only 139 DPRs out of 171 projects have been uploaded in the website. The remaining 42 DPRs will be uploaded by August 2012.

(iv) With regard to data entry in the online MIS, the State representative assured that the same would be completed within August 2012 & then would be updated on regular basis.

(v) After detailed deliberations, the Committee appraised & cleared 98 projects covering an area of **4.05870** lakh ha in 12 Districts of Andhra Pradesh for the year 2012-13. The list of projects appraised & cleared is at **Annexure-II**.

4. Gujarat

(i) The CEO, SLNA, Gujarat made a presentation on the progress of the IWMP projects sanctioned to State during 2009-10, 2010-11 & 2011-12. The State has proposed to treat 319 micro-watersheds over an area of 5.46 lakh ha against the allocated target of 3.15 lakh ha for 2012-13.

(ii) The progress in the engagement of experts & staff in the dedicated institutions set up at different levels was found to be satisfactory. Though the progress of capacity building of various stakeholders is satisfactory, the Committee observed that the expenditure under this component is very low i.e. 8.16 % of available funds.

(iii) It was informed that EPAs for the projects sanctioned during 2009-10 have been completed. For the projects sanctioned during 2010-11, an amount of Rs. 22.03 crore has been spent against the available funds of Rs. 36.71 crore and for the 2011-12 projects, an amount of Rs.2.29 crore has been spent against the total available funds of Rs. 27.45 crore. Regarding status of expenditure under IWMP, Committee advised to expedite the implementation so that the expenditure will improve.

(iv) The State representative mentioned that DPRs have been prepared for all the 292 projects sanctioned in 2009-10 & 2010-11 and uploaded on the website. DPRs for the projects sanctioned in 2011-12 will be completed by Sept, 2012.

(v) Regarding pre-IWMP projects (DPAP, DDP & IWDP), the State representative assured to comply on the observations of DoLR and furnish the pending documents. He also assured to furnish proposals for claiming the pending installments in all the remaining ongoing projects. With reference to foreclosed pre-IWMP projects, it was informed that all relevant documents will be furnished at the earliest.

(vi) The Committee also observed that NGOs are not being engaged as PIAs in the State of Gujarat. The State representative clarified that as per the State Government's policy, NGOs are not being engaged as PIAs at present and the involvement of NGOs is limited only to the capacity building aspect of the programme.

(vii) The State representative also informed that for the monitoring purpose, each project and activity is geo tagged and the java enabled mobile devices are being used for effective monitoring of the programme.

(viii) A brief over-view of the EPAs and some of the works undertaken was also presented before the committee. After viewing the photographs, the chairperson desired to see the project area of IWMP-IV in Valsad district.

(ix) Thereafter, CEO, SLNA, Gujarat made district-wise presentation on the projects proposed to be taken up for 2012-13. The Committee deliberated upon the proposals of the SLNA, Gujarat and appraised & cleared projects covering an area of 3.178 lakh ha. only in 26 Districts of Gujarat for the year 2012-13 as per the target allocated to State. The additional projects covering an area of 2.282 lakh ha will be examined in December, 2012, after taking stock of the demands received from other States. The list of projects appraised & cleared is at **Annexure-II**.

5. Jharkhand

(i) The Principal Secretary, Rural Development, Govt. of Jharkhand made a presentation on the progress of watershed projects in Jharkhand. The State has proposed to take up 30 new projects in 1.63 lakh ha for the year 2012-13, including **Sarju Development plan under IAP District**, in Latehar district, against the allocated target of 1.45 lakh ha.

(ii) The State representative informed that the 2nd and 3rd batch of IWMP projects are in preparatory phase and the DPRs for the 2nd and 3rd batch will be completed by October, 2012 and Jan, 2013 respectively. He also assured to upload the same at the earliest.

(iii) The Committee desired to expedite implementation of projects especially the first two batches. On this, the State representative assured to expedite the pace of implementation of the same.

(iv) Regarding the fund requirement for the current financial year, the Chairperson clarified that the State should furnish their annual fund requirement for 2012-13 as per the recently issued operational guidelines on central fund release mechanism by DoLR.

(v) Regarding the completion and foreclosure of the pre-IWMP (DPAP & IWDP) projects, the State representative informed that this issue is being reviewed with the concerned DDCs for doing the needful in this regard at the earliest. The Chairperson directed the State representative to take urgent action in this regard and furnish the requisite documents immediately to DoLR.

(vi) The committee observed that the data entry in IWMP-MIS needs to be updated. On this, the State representative informed that the passwords for 45 projects for entering the data have recently been obtained from NIC and the entries in MIS will be updated at the earliest.

(vii) The State representative made a presentation on district-wise projects proposed to be taken up during 2012-13. After discussions on the District-wise proposals for 2012-13, the Committee appraised & cleared projects covering an area 1.63 lakh ha in 15 Districts of Jharkhand. The list of projects appraised & cleared is at **Annexure-II**.

6. Meghalaya

(i) The CEO cum Director, Soil and Water Conservation Department, Meghalaya made a presentation on the progress of ongoing watershed projects in the State. He proposed to take up new projects covering a total area of 0.3887 lakh ha during the year 2012-13 against the minimum tentative target of 0.34 lakh ha allocated by DoLR.

(ii) Regarding the progress in the engagement of experts & staff in the dedicated institutions set up at different levels, it is observed that the State has made good

progress in positioning the experts and staff at various levels except at state level where process of engaging staff is under progress.

(iii) The Committee observed that the State has utilized complete funds released for the projects sanctioned in 2009-10, 2010-11 and 2011-12 for the purpose of capacity building, EPAs and DPR preparation, although the evaluation of preparatory phase is yet to be started/ completed for these batches. The State representative was advised to relook into the figures. The State representatives assured to relook into the same. Further, it was observed that DPR preparation has been completed for three batches but only 2009-10 and 2010-11 DPRs have been uploaded on the website. The State representative assured to upload all the DPRs prepared so far.

(iv) The State representative informed that all the pre-IWMP projects will be completed within the time schedule communicated by the Department.

(v) The State representative informed that all the necessary documents like UCs and Audited Statement of Accounts pertaining to IWMP projects will be submitted within two months. The State has submitted the Annual Requirement of Funds for 2012-13.

(vi) The Committee observed that data entry in IWMP-MIS needs to be expedited. Only 44 out of 61 PIA have requested for user ID. Project funds have been transferred from WCDC to PIA in only 7 out of 61 projects. State has yet to enter State profile. No project has entered baseline survey details and physical/financial achievement in IWMP-MIS. State representative assured to complete the data entry in MIS at the earliest.

(vii) The Committee deliberated upon the proposal of the State Government and appraised & cleared 12 projects covering an area of 38870 ha in 7 Districts of Meghalaya for the year 2012-13. The list of projects appraised & cleared is at **Annexure-II**.

7. Tamil Nadu

(i) The CEO SLNA made a presentation on project proposals for the year 2012-13 under IWMP. The SLNA proposed to treat 32 projects in 19 districts over an area of 1.71534 lakh ha against the allocated target of 1.55 lakh ha.

- (ii) Regarding the progress of ongoing Hariyali projects, CEO SLNA assured to submit the proposal for claim of balance installments for the 45 ongoing pre-IWMP projects (23-IWDP & 22-DPAP) by September 2012. The CEO also assured to submit the pending UC's for an amount of Rs 10.21 crore by August 2012. Further, the State representative informed that all the requisite documents for foreclosure of 2 out of 3 identified non-performing projects have already been submitted and the requisite documents for the remaining one non-performing DPAP project would be submitted by August 2012.
- (iii) The progress of engagement of experts & staff in the dedicated institutions at different levels was found to be satisfactory.
- (iv) The State representative informed the Committee that DPRs for all the 50 projects sanctioned during 2009-10 and 62 projects sanctioned during 2010-11 have been prepared and uploaded in the website. The DPRs of the 56 projects sanctioned during 2011-12 would be uploaded on the website within a week. The CEO SLNA informed that the proposal along with Annual requirement of funds for the year 2012-13 has been submitted to the Department for consideration.
- (v) After detailed deliberations, the Committee appraised & cleared 32 projects covering an area of **1.71534 lakh** ha in 19 Districts of Tamil Nadu for the year 2012-13. The list of projects appraised & cleared is at **Annexure-II**.
