I am directed to convey the approval of the President of India for release of **Rs.100.00 crore (Rupees One Hundred Crore only)** as 1st instalment of Central share for 2015-16 for implementation of IWMP projects under watershed component of **Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) in Gujarat.**

Through this Sanction Order, sanction of the President of India is hereby conveyed for release of **Rs.83.50 crore (Rupees Eighty Three Crore Fifty Lakh only)**, as mentioned in para 2 (i) above, to the State Government of **Gujarat** for implementation of above projects. The expenditure is debitable to the Head of Account given below:-

- The projects proposed to be taken up during 2015-16 as well as the amount of funds required have the approval of State Level Sanctioning Committee (SLSC) in terms
