**SUBJECT: Release of 1<sup>st</sup> installment of funds for the year 2015-16 for implementation of IWMP projects under Watershed Component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) in Manipur - reg.**

Sir,

I am directed to convey the approval of the President of India for release of **Rs.09.00 crore (Rupees Nine Crore only)** as 1st instalment of Central share for 2015-16 for implementation of IWMP projects under Watershed Component of **Pradhan Mantri Krishi Sinchayee Yojana (PMKSY)** in Manipur State.

2. The total amount of **Rs.09.00 crore** to be released under the following Budget Heads-

3. Through this Sanction Order, sanction of the President of India is hereby conveyed for release of **Rs 3.681 crore (Rupees Three Crore Sixty Eight lakh and One Thousand only)**, as mentioned in para 2(i) above, to the State Government of **Manipur** for implementation of above projects. The expenditure is debitable to the Head of Account given below:-

**Demand No.85- Department of Land Resources**

3601 – Grants in Aid to State Government (Major Head)

02 - Grants for State Plan Schemes (Sub-Major Head)

**796 - Tribal Area Sub Plan (Minor Head)**

62–Pradhan Mantri Krishi Sinchayee Yojana (Watershed Component)

62.00.31- Grants in aid (Scheduled Tribal Sub Plan (2015-16) – **Rs 3.681 Crore**

4. The above release of Central assistance is subject to the following conditions:-

- i. This release of 1<sup>st</sup> instalment 2015-16 is provisional subject to the strict condition for Programme Division and SLNA, Manipur that all discrepancies in UCs/ASAs with respect to opening and closing balances or any other must be resolved and rectified in every case before coming up for further release of funds as second instalment or also the next release in case there is no proposal for 2<sup>nd</sup> instalment-2015-16.
- ii. The funding pattern between Centre & State is 50:50 with the exception of existing funding pattern for the NE Region and Hilly States for Watershed Component of PMKSY (erstwhile IWMP projects)
- iii. The projects proposed to be taken up during 2015-16 as well as the amount of funds required have the approval of State Level Sanctioning Committee (SLSC) in terms of para 16.0 of PMKSY Guidelines.
- iv. Priority should be given for saturation of projects which are nearing completion in convergence with MGNREGA.
- v. The State Government should release its equivalent share towards the scheme.

5. The State Government shall transfer the funds to State Level Nodal Agency for IWMP immediately. Purchase of vehicles/ photocopier/Video Recorder/ Projector, construction of any permanent buildings and such other capital items is not allowed under the Programme. Further the State Government should ensure to minimize the unspent balance for all projects under the programme, to upload the DPRs on the website and to update MIS at all levels regularly. The other terms and conditions mentioned in the Annexure-I attached with Sanction Order No. 01 of Manipur in 2015-16.


6. The implementing agency shall maintain proper accounts of the expenditure incurred and submit the statement of audited accounts and Utilization Certificates to this Department as soon as possible after the closure of the financial year. The implementing agency shall furnish consolidated monthly progress report regularly with details of physical and financial achievements. The Implementing Agency will follow other terms and conditions contained in the General Financial Rules 2005, as amended from time to time.

7. The Pay and Accounts Officer, Department of Land Resources, Ministry of Rural Development will be the Drawing and Disbursing Officer for this purpose. The amount will be transferred to the State Government of **Manipur**.

8. The Accounts of the grantee institution or organization shall be opened to Internal Audit of the Pr. Accounts Office functioning under Chief Controller of Accounts, in term of Rule 211(1) of GFR 2005. The Accounts of the grantee institutions is liable to be audited by the Comptroller and Auditor General of India.

9. This issues under the powers delegated to the Ministry of Rural Development and in consultation with the IFD vide their **UO. No.173/ IFD/LR/2015-16 dated 15/10/2015**.
