In continuation of this department's sanction order No.1/Chhatisgarh /2015-16/IWMP dated 16.10.2015, I am directed to convey the approval of the President of India for release of **Rs.20.00 crore (Rupees Twenty Crore only)** as 1st instalment of Central share for 2015-16 for implementation of IWMP projects under watershed component of **Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) in Chhatisgarh.**

2. The total amount of **Rs.20.00 crore** to be released under the following Budget Heads:

3. Through this Sanction Order, sanction of the President of India is hereby conveyed for release of **Rs.3.30 crore (Rupees Three Crore Thirty Lakh only)**, as mentioned in para 2 (ii) above, to the State Government of **Chhatisgarh** for implementation of above projects. The expenditure is debitible to the Head of Account given below:-

4. The above release of Central assistance is subject to the following conditions :-

- The projects proposed to be taken up during 2015-16 as well as the amount of funds required have the approval of State Level Sanctioning Committee (SLSC) in terms
