In continuation of this department's sanction order No. 1/Maharashtra /2015-16/IWMP dated 27.8.2015, I am directed to convey the approval of the President of India for release of **Rs.250.00 crore (Rupees Two Hundred Fifty Crore only)** as 1st instalment of Central share for 2015-16 for implementation of IWMP projects under watershed component of **Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) in Maharashtra.**

2. The total amount of **Rs.250.00** to be released under the following Budget Heads:

Through this Sanction Order, sanction of the President of India is hereby conveyed for release of **Rs.41.25 crore (Rupees Forty One Crore Twenty Five Lakh only)**, as mentioned in para 2 (ii) above, to the State Government of **Maharashtra** for implementation of above projects. The expenditure is debitable to the Head of Account given below:-
