**Monthly summary of important activities of Department of Land Resources during March, 2021**

Unique Land Parcel Identification Number (ULPIN), a 14 digit – Alpha-numeric unique ID for each land parcel based on Geo-coordinates of vertices of the parcel which is of international standard and which complies with Electronic Commerce Code Management Association (ECCMA) and Open Geospatial Consortium (OGC) standard was rolled out in States / UTs as below:

Secretary led the team of DoLR in the World Bank meeting held on 08.03.2021 regarding World Bank assisted new multi-State Watershed Project “Rejuvenating Watershed for Agricultural Resilience through Innovative Development (REWARD)”.

Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 4792 projects have been completed till date out of the 6382 {8214 (sanctioned) – 1832 (transferred to States)}. End line evaluation of 2862 projects has been completed till now.

The current status of progress (cumulative) of different components of Digital India Land Records Modernization Programme (DILRMP) is as follows: -

- i. Computerization of Land Records of 6,00,167 Villages completed.
- ii. Computerization of Registration 4,862 SROs completed.
- iii. Digitization of 1,10,06,245 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of 3,943 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 2,194 Tehsils completed.

The Department has incurred an expenditure of Rs.1236.50 Crore which is 99% of the Revised Estimates of Rs.1252.15 Crore during the financial year 2020-21.
