Monthly Summary of principal activities and important decisions taken by the Department of Land Resources during November, 2020.

A meeting with Additional Chief Secretaries/Principal Secretaries of State Governments on enactment / amendment in Revenue Acts / Rules/ Policies empowering/ authorizing to issue Property Card under SVAMITVA (Survey of Villages Abadi and Mapping with Improvised Technology In Village Areas) Scheme as a title-deed to secure loans on the basis of entries made in the Property Card was held through VC on 04-11-2020 at 3.30 P.M. under the Chairmanship of Secretary (Land Resources).

A Committee under the Chairmanship of Additional Secretary (LR) on linking of e-Court with land records and registration data base comprising the members from Department of Justice, eCourt Committee of Supreme Court and state Governments have been constituted on 18.11.2020 to undertake pilot test in Haryana, Maharashtra and Uttar Pradesh and submit its report.

A Meeting with the Stake holders of Delhi and Mumbai to review action taken on parameters / reforms and action plan to improve ranking in Registering Property indicator of Ease of Doing Business was held through V.C. on 18.11.2020 under the Chairmanship of Secretary(Land Resources).

An Inter-Ministerial Meeting with Ministry of Home Affairs and Ministry of Environment, Forest and Climate Change (MoEFCC) was held on 25.11.2020 under the chairmanship of Secretary(Land Resources) in respect of long pending Parliament Assurances on Lok Sabha Q. No.3451 and Lok Sabha Q. No 1552.

The Department organized a Video Conference on 11.11.2020 on Sustainable Land and Ecosystem Management with the Consultants of Ministry of Environment Forests & Climate Change.

Secretary, Department of Land Resources held a meeting on proposed REWARD scheme with World Bank team on 12.11.2020.

Secretary, Department of Land Resources discussed the EFC proposal for Watershed Development Component - Pradhan Mantri Krishi Sinchai Yojana (WDC-PMKSY) in a meeting with Secretary, Ministry of Jal Shakti and Secretary, Department of Expenditure on 18.11.2020 and 24.11.2020, respectively.

Under Digital India Land Records Modernization Programme (DILRMP), Rs.70.67 crore against the Budget Allocation of Rs.238.65 crore (2020-21) has been

released in November, 2020. The progress of the different components of DILRMP is as follows:

- i. Computerization of Land Records of 596,657 Villages completed.
- ii. Computerization of Registration of 4741 SROs completed.
- iii. Digitization of 106,57,881 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of 3730 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 2145 Tehsils completed

Under WDC-PMKSY, 4707 watershed development projects have been completed till date out of the total 6382 {8214 (sanctioned) - 1832 (transferred to States)}. Rs.109.25 crore against the total Budget Allocation of Rs.2000 crore (2020-21) has been released in November, 2020.
