Monthly Summary of principal activities and important decisions taken by the
Department of Land Resources during June, 2020

National Generic Document Registration System (NGDRS) has been launched in two SROs of Union Territory of Jammu and Kashmir on 15th June, 2020. Meetings through Video Conferencing were conducted on 8th June and 19th June 2020 respectively with the Revenue Secretary, Government of Goa to provide technical support to them to adopt Bhunaksha under the Digital India Land Records Modernization Programme (DILRMP).

Under Digital India Land Records Modernization Programme (DILRMP), Rs.23.85 crore has been released in June, 2020 against the Budget Allocation of Rs.238.65 crore for 2020-21.

Department reviewed the implementation of WDC-PMKSY covering all States through three Video Conferences (VCs) held on 02.06.2020, 17.06.2020 and 26.06.2020. In spite of Covid-19, during this quarter 467 watershed development projects were completed. 3709 watershed development projects have been completed till date out of the total 6382 {8214 (sanctioned) - 1832 (transferred to States)}. Rs.88.05 Crore has been released in June, 2020 against the Budget Allocation of Rs.2000 crore for 2020-21.

The World Bank organized a Video Conference meeting with partner States and DoLR officials on 09.06.2020 to review the progress of REWARDS project. States informed about the creation of budget lines, State Level PMUs and other preparatory activities. DoLR apprised about the progress towards establishing PMU at National Level.
