Monthly summary of important activities of Department of Land Resources during November, 2021

A National Workshop on Digital India Land Records Management Programme (DILRMP) was held on 16th November, 2021 under the Chairmanship of Shri Giriraj Singh, Hon'ble Minister of Rural Development & Panchayati Raj. Shri Faggan Singh Kulaste, Hon'ble Minister of State (RD and Sadhvi Niranjan Jyoti, Hon'ble Minister of State (RD and CA, F&PD) graced the occasion. Shri Govind Singh Rajput, Hon'ble Revenue Minister, Madhya Pradesh also joined the Workshop.

Senior Officers from 27 States/UTs participated in the National Workshop. 10 States namely Assam, Andhra Pradesh, Bihar, Himachal Pradesh, Madhya Pradesh, Chhattisgarh, Rajasthan, Odisha, Tripura & Uttar Pradesh presented their best practices adopted in DILRMP during the Workshop.

Hon'ble Minister of Rural Development and Panchayati Raj launched National Generic Document Registration System (NGDRS) portal during the opening ceremony of National Workshop.

- 2. Hon'ble MoRD inaugurated the new office of Watershed Management Division of the Department at Shivaji Stadium Office Complex on 23.11.2021. Hon'ble Minister of State of Rural Development and Minister of State of Panchayati Raj also graced the occasion.
- 3. Hon'ble MoRD inspected the NBO Office premises of the Department on 18.11.2021 to assess the achievements made under the Special Campaign on disposal of pending references and cleanliness.
- 4. Hon'ble MoRD held a meeting on 17.11.2021 on exploring convergence opportunities of Horticulture Mission in watershed areas with Ministry of Agriculture.
- 5. Secretary(LR) held a meeting through Video Conference (VC) with States/UTs on 30th November, 2021 to review preparedness and demonstration of the Software/MIS for land acquisition ranking of States / UTs, as directed by Cabinet Secretary.
- 6. Additional Secretary (LR) led the Department alongwith Additional Secretary & Financial Adviser on 10.11.2021 for negotiation of REWARD project with World Bank team.
- 7. Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 5161 projects have been completed till date out of the total 6382 {8214 (Sanctioned)-1832 (transferred to States)}. End line evaluation of 3838 projects has been completed till now.

- 8. The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows:
 - i. Computerization of Land Records of 6,01,125 Villages completed.
 - ii. Computerization of Registration 4,883 SROs completed.
- iii. Digitization of 1,10,94,349 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of 3,983 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 2,508 Tehsils completed.
