Monthly summary of important activities of Department of Land Resources during December, 2021

Hon'ble Minister of Rural Development and Panchayati Raj launched Management Information System (MIS) portal on 16.12.2021 for rankings of States/UTs in Land Acquisition Projects under Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (RFCTLARR) Act, 2013.

2. Hon'ble MoS (RD & Steel) inspected the office premise of Department of Land Resources at CGO Complex on 01.12.2021 to assess the achievements made under the Special Campaign on disposal of pending references and cleanliness.
3. Secretary (LR) chaired the Breakout Session on Theme 3 : Effective Grievances Redressal in the National Workshop organised by DPIIT on 22.12.2021 on the next phase of Reforms for Reducing Compliance Burden in the Good Governance Week organized by DARPG during 20.12.2021 to 25.12.2021.
4. Creation of REJUVE Wellness Centre by the Department of Land Resources during the Special Campaign on disposal of pending references and cleanliness held during September to November, 2021 has been recognised in the Good Governance Week (GGW) as a special achievement.
5. Secretary (LR) held a meeting on 02.12.2021 with representatives of *Mission for Integrated Development of Horticulture (MIDH)*, Ministry of Agriculture and Farmers Welfare and suggested them to give inputs for enhancing horticultural potential in the States.
6. Secretary (LR) reviewed the implementation of projects under WDC-PMKSY through a VC with States / UTs on 23.12.2021.
7. World Bank assisted Program on "Rejuvenating Watersheds for Agricultural Resilience through Innovative Development (REWARD) has been approved by the World Bank on 10.12.2021.
8. New generation of watershed scheme i.e. WDC-PMKSY 2.0 for the development of 4.95 million ha. of rainfed/ degraded areas has been approved by the Government on 15.12.2021 with an outlay of Rs. 8134.00 crore (Central Share) for a period of 2021-22 to 2025-26.

9. Approval of Hon'ble Finance Minister on recommendations of Expenditure Finance Committee (EFC) on Digital India Land Records Modernization Programme (DILRMP) has been conveyed by the Department of Expenditure on 20.12.2021.

10. Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 5220 projects (81.79%) have been completed till date out of the total 6382 {8214 (Sanctioned) - 1832 (Transferred to State)}. End line evaluation of 3887 projects has been completed till now.

11. The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows:-

- i. Computerization of Land Records of 6,07,269 Villages completed.
- ii. Computerization of Registration 4,883 SROs completed.
- iii. Digitization of 1,11,03,464 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of 3,983 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 2,510 Tehsils completed.
