Monthly summary of important activities of Department of Land Resources during August, 2022.

As a major activity during the month of August, 2022, Department of Land Resources organised 'Har Ghar Tiranga' programme at Shaheed Smarak, Jabalpur, Madhya Pradesh in partnership with the Government of Madhya Pradesh on 14.08.2022. Shri Faggan Singh Kulaste, Hon'ble Minister of State (Rural Development & Steel) graced the occasion. During the event, following activities were taken up -hoisting of National Flag, felicitation of tributes to Martyrs/Freedom Fighters, family Members of Martyrs /Freedom Fighters, Public Meeting reflecting Jan Bhagidari. People from various sections of society enthusiastically participated in the event.

The Department procured and distributed National Flags to its employees as per instructions from Cabinet Secretary and Ministry of Culture. Selfie-points were erected at 'NBO Building' for taking selfie with the National Flag on 12.08.2022 and photographs were widely shared in the social media.

- 2. The Department of Land Resources was ranked at No. 1 in terms of Grievance Redressal Index of CPGRAMS Portal for the month of July, 2022 as communicated by the Department of Administrative Reforms & Public Grievances (DAR&PG) vide its letter 01.08.2022.
- 3. A review meeting on Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY 2.0) was taken by Hon'ble MoS of Panchayati Raj on 17.08.2022.
- 4. Unique Land Parcel Identification Number (ULPIN) has been rolled in the State of Himachal Pradesh in the month of August, 2022.
- 5. A Project Sanctioning and Monitoring Committee (PS&MC) meeting was held on 5.8.2022 with States/UTs under the Chairmanship of Secretary, DoLR for release of funds to States/UTs under Digital India Land Records Modernization Programme (DILRMP).
- 6. Secretary, DoLR chaired a Video Conference meeting with National Remote Sensing Centre(NRSC) on 18.08.2022 on various issues faced by NRSC.
- The team of Capacity Building Commission held two workshops in NBO building in August 2022. Senior officers were present in the meetings.
- 8. Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 6031 projects have been completed till date out of the total 6382 {8214 (Sanctioned) 1832 (Transferred to State)}. End line evaluation of 5458 projects has been received till now.

- 9. The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows:
 - i. Computerization of Land Records of 6,16,657 Villages completed.
 - ii.Computerization of Registration 4,893 SROs completed.
 - iii. Digitization of 11,730,286 Cadastral Maps/FMBs/Tippans completed.
 - iv.Integration of 4,021 SROs with land records completed.
 - v.Establishment of Modern Records Rooms in 2,795 Tehsils completed.
