Monthly Summary of principal activities and important decisions taken by the Department of Land Resources during August, 2020

A Committee has been constituted in the Department of Land Resources by the competent authority on 28.08.2020 under the Chairmanship of Secretary (Land Resources) to suggest a way forward on land leasing in order to facilitate extension of benefits of Central Government Schemes to the actual tillers/cultivators on one hand and to protect the interest of land owners on the other.

Department of Land Resources reviewed the implementation of WDC-PMKSY through a Video Conferencing (Webex) with all the 28 States on 14.08.2020.

World Bank Team had two interactions with Secretary (Land Resources) through Webex on 24.08.2020 and 31.08.2020 respectively and discussed the progress made under REWARD project including by the partner States of REWARD and future plan of action. The DoLR also apprised about the status on its preparedness.

From 24.08.2020 to 31.08.2020, the World Bank Team conducted 3rd preparation Mission on REWARD project. The Mission had Webex meeting with Senior Officers of participating States viz. Andhra Pradesh, Karnataka & Odisha.

Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 4400 watershed development projects have been completed till date out of the total 6382 {8214 (sanctioned) - 1832 (transferred to States)}. Rs.100.00 crore against the Budget Allocation of Rs.2000 crore has been released in August, 2020 during 2020-21. Under Digital India Land Records Modernization Programme (DILRMP), Rs.11.64 crore against the Budget Allocation of Rs.238.65 crore has been released in August, 2020 during 2020-21.
