Monthly Summary of principal activities and important decisions taken by the Department of Land Resources during January, 2021

Ministry of Defence on 27.01.2021 was notified "appropriate Government" under sub-clause (v) of clause (e) of Section 3 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013) for acquisition of land at Yorni-II, District West Siang, Arunachal Pradesh for establishing military garrison and locating various army detachments.

EFC Memo for extension of DILRMP for 3 years (1.4.2021 to 31.3.2024) has been concurred by IFD and approved by the Hon'ble Minister of Rural Development with introduction of 3 new components viz. (i) District Level Modern Record Room (ii) Integration of Aadhaar Number with Land Records (iii) Integration of Land Records with Revenue Court Management System (e-RCMS). The same has been circulated to NITI Aayog and concerned Ministries for their comments/views.

The current status of progress of different components of Digital India Land Records Modernization Programme (DILRMP) is as follows: -

- i Computerization of Land Records of 5,98,290 Villages completed.
- ii. Computerization of Registration 4861 SROs completed.
- iii. Digitization of 1,09,10,562 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of 3924 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 2162 Tehsils completed.

The Department of Land Resources took part in the discussion held by International Water Management Initiative (IWMI), held on virtual platform on 07.01.2021 and highlighted the development of Rainfed and Degraded lands made under the scheme of WDC-PMKSY.

Secretary(LR) visited Tapin and Gola (in Jharkhand) Watershed Projects under WDC-PMKSY on 3rd of January 2021 and reviewed the progress; while Additional Secretary(LR) along with the concerned Joint Secretary visited Hyderabad to review the implementation of WDC-PMKSY.

Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 4743 projects have been completed till date out of the total 6382 projects {8214 (sanctioned) - 1832 (transferred to States)}. Rs.123.06 crore has been released in January, 2021 with cumulative release of Rs. 777.42 crore against the Revised Allocation of Rs.1000 crore.
