Sir,

I am directed to refer to LBSNAA letter No.A-11011/3/2018-CRS dated 27.07.2022 and PSMC meeting held on 5.8.2022 on the subject mentioned above and to convey the approval of the competent authority towards release of an amount of **Rs. 31153185/- (Rs. Three Crore Eleven Lakh Fifty Three Thousand One Hundred and Eighty Five only) as 1st installment (25% of Rs. 124612740 /-) during 2022-23 to Centre for Rural Studies, Lal Bahadur Shastri National Academy of Administration (LBSNAA), Mussoorie. Details of year-wise proposals are given as under:**

2. The release of the grant is subject to the following conditions:

- To make the study independent, the Centre should preferably allocate it to the independent government organization duly following the GFR and to be decided by the committee headed by the Director, LBSNAA.
- CRS would submit action plan of proposed activities to be undertaken during next four (4) months (September-December, 2022) out of the approved activities for 2022-23 to the DoLR before their commencement for approval.
- 2nd Installment (Rs. 31153185/-) will be released only after utilization of 75% of expenditure of 1st Installment by the LBSNAA along with the Utilization Certificate in due course of time.
- Fund shall be utilised for the purpose it has been released. No diversion of funds is permissible.
- Centre shall submit necessary bills/vouchers furnished by the vendor on completion of different milestones of work which are entered in the Receipt Expenditure Advance Transfer (REAT) module of Public Finance Management.

- vi. Centre shall submit item-wise expenditure and utilization certificate separately in the prescribed proforma in respect of the funds released.
- vii. Centre should implement REAT Module of Public Financial Management System (PFMS) and register the vendors immediately, if not already done for future releases. *This may require for further release of fund by this Department.*

3. The above expenditure of Rs. 31153185/- (Rs. Three Crore Eleven Lakh Fifty Three Thousand One Hundred and Eighty Five only)is to be met from the sanctioned Budget Grant for the year 2022-23 under Demand No. 88 – Department of Land Resources. The details of Head is given below:
