3. The release of grant is subject to the following terms and conditions:

- I. The DILRMP shall be implemented as per the Guidelines of the Programme.
- II. 2nd Installment (Rs. 315.512 Lakh) will be released only after due confirmation of expenditure of 75% of 1st Installment by the UT along with the Utilization Certificate in due time.
- III. The UT shall strictly adhere to the financial and purchase of service norms of the Central / State Government in vogue, suggestions / remarks given by NIC as well as norms prescribed by NICS1 for hiring manpower etc.
- IV. The UT shall follow the prescribed procedure for purchase of the approved items.
- V. The fund shall be utilized for the purpose for which it has been sanctioned. No diversion of funds is permissible.
- VI. The UT shall submit item-wise expenditure and physical progress and utilization certificate separately for the project fund, PMU and NLRMP Cell in the prescribed formats in respect of the funds released under the scheme.
- VII. The UT shall ensure that expenditure is incurred only on approved activities as per the guidelines and circulars issued by this Department from time to time.
- VIII. The UT shall follow Receipt Expenditure Advance Transfer (REAT) Module in the Public Financial Management System (PFMS).
- IX. **The fund sanctioned under SC/ST component shall be spent in SC/ST dominated areas and their records should be maintained separately (e.g. village wise, Scheduled Block wise, no of persons benefited, etc.) and may be shared with DoLR.**
- X. **The Administration/ Department is requested to give adequate publicity about the DILRMP and its components. The programme assistance by 'Department of Land Resource, Ministry of Rural Development, Government of India' may be given due recognition during foundation stone laying/inauguration/important meetings etc., wherever applicable.**

4. All activities sanctioned under the programme shall be completed by the UT within the financial year 2022-23.

5. The Section Officer (Admn), Department of Land Resources, Ministry of Rural Development shall be the Drawing and Disbursing Officer for this purpose and the amount shall be transferred as per the details given below:
