

Monthly Summary of principal activities and important decisions taken by the  
Department of Land Resources during February, 2019 –reg.

1. 8214 watershed development projects were sanctioned during 2009-10 to 2014-15 in 28 States (except Goa) under Integrated Watershed Management Programme and later amalgamated under WDC-PMKSY. Under the WDC-PMKSY 505 projects have been reported completed during the month totaling it to 2268 projects completed upto February, 2019.
2. An amount of Rs.1367.61 crores was released to the States upto February, 2019 for watershed development under WDC-PMKSY including Neeranchal.
3. An amount of Rs.43.41 crores have been released to the States upto February, 2019 during this financial year under Digital Land Records Modernization Programme (DILRMLP).
4. Regional Conference on DILRMP and Watershed Development Component of PMKSY (WDC-PMKSY) was held on 14<sup>th</sup> and 15<sup>th</sup> February, 2019 at Jammu, Jammu & Kashmir to review the progress and other implementation aspects of various components of DILRMP and WDC-PMKSY in the States of Haryana, Himachal Pradesh, Jammu & Kashmir and Punjab.
5. Similarly, a Regional Conference of West Zone was held under the Chairmanship of Secretary (LR) at Vadodara on 26.02.2019, wherein various components of DILRMP were reviewed with the senior officials of the States of Gujarat, Madhya Pradesh, Maharashtra, Chattisgarh and Rajasthan.
6. As per the instructions of the Cabinet Secretariat, a task force on 'Ease of Doing Business' has been constituted under the Chairmanship of Special Secretary (LR). The reforms/measure under Ease of Doing Business is being regularly followed up with the stakeholders viz. NCT Delhi, DDA, Municipalities of Delhi, Maharashtra, Ministry of Urban Development etc.
7. The first meeting of Sub-Committee on Land related issues was held on 05.02.2019 under the chairpersonship of Special Secretary. The meeting was attended by representatives from member Ministries /Departments such as Panchayati Raj, Tribal Affairs, Agriculture Cooperation and Farmers Welfare, Environment Forest and Climate Change, Rural Development, Legal Affairs, Social Justice and Empowerment and Panchayati Raj Departments of Rajasthan, Madhya Pradesh, and Andhra Pradesh.
8. Meetings with State Governments / stake holders through video conference are being held under the initiatives during the month under 'Minimum Government, Maximum Governance'.
