Monthly summary of important activities of Department of Land Resources during July, 2021

In compliance of DoLR's Action Plan on Azadi Ka Amrut Mahotsav, two Regional Meetings and Campaigns on the benefits of National Generic document Registration System (NGDRS) and Unique Land Parcel Identification Number (ULPIN) were held on 10.7.2021 at Agartala, Tripura and on 19.7.2021 at DC office Complex, Kathua and ADC/SRO office, Billowar (J&K) respectively.

Besides that Pilot testing of ULPIN has been completed successfully in the State of Assam on 26.7.2021.

The Committee on linking of e-Court with Land Records and Registration data base constituted by the Department of Land Resources and headed by Additional Secretary (LR) submitted its report on 15.7.2021.

Secretary (LR) made a presentation on Data Generation Quality Index (DGQI) in the Webinar-review meeting held on 29.07.2021 under the chairmanship of Advisor to the Hon'ble PM.

The office of Principal Scientific Adviser to Government of India vide OM dated 23.3.2021 has constituted the Standing Committee on Rural Development and Panchayat Development under the Space Application Management System (SAMS) mechanism as the body to deal with Space Technology related applications in the domain of Land Resources, Rural Development and Panchayati Raj. The first meeting of this Committee was held under the chairmanship of Secretary (LR) on 28.7.2021.

The Department transitioned its e-office version from 5.6 to 6.0 on 28.7.2021. As part of Department efforts towards increasing efficiency in decision making, the Department reviewed its Level of Disposal, Channel of Submission and Delegation of Financial Powers in a meeting held on 27.7.2021.

Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 4866 projects have been completed till date out of the total 6382 {8214 (sanctioned) - 1832 (transferred to States)}. End line evaluation of 3186 project has been completed till now.

The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows: -

- i Computerization of Land Records of 6,00,708 Villages completed.
- ii. Computerization of Registration 4,870 SROs completed.
- iii. Digitization of 1,10,06,702 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of 3,971 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 2,322 Tehsils completed.
