

**Monthly summary of important activities of Department of Land Resources during October, 2021**

Ministry of Defence on 5.10.2021 was notified "appropriate Government under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013) for acquisition of certain land in Arunachal Pradesh.

2. Secretary(LR) chaired a meeting on 04.10.2021 on formulation of "Matribhoomi" – an integrated Land Information Management System of the Department which is being developed.
3. The Department held a meeting through Video Conference (VC) on 20.10.2021 with C-DAC team Pune to review the progress of development of software for multilingual land records.
4. Secretary(LR) chaired a meeting through Video Conference (VC) on 26.10.2021 to review the progress of PFMS implementation in all States/UTs.
5. Progress on Special Campaign on disposal of pendency and cleanliness was reviewed by Secretary(LR) through a series of meeting held on 7<sup>th</sup>, 12<sup>th</sup>, 14<sup>th</sup> & 25<sup>th</sup> October, 2021 and inspected all the premises on 18<sup>th</sup>, 20<sup>th</sup> & 22<sup>nd</sup> October, 2021.
6. As part of "Special Campaign for disposal of Pendency and Cleanliness" undertaken during 2<sup>nd</sup> - 31<sup>st</sup> October, 2021, the Department has reviewed 11028 files and weeded-out 5734 obsolete and old files. As a result of weeding out of file, removal of electronic scraps and condemned vehicles, 2206 sq. ft. of space has been freed.
7. Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 5151 projects have been completed till date out of the total 6382 {8214 (Sanctioned)-1832 (transferred to States)}. End line evaluation of 3807 projects has been completed till now.
8. The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows: -
  - i. Computerization of Land Records of 6,00,879 Villages completed.
  - ii. Computerization of Registration 4,883 SROs completed.
  - iii. Digitization of 11,094,349 Cadastral Maps/FMBs/Tippans completed.
  - iv. Integration of 3,971 SROs with land records completed.
  - v. Establishment of Modern Records Rooms in 2,508 Tehsils completed.
