Monthly summary of important activities of Department of Land Resources during March, 2023.

The Consultative Committee meeting of Ministry of Rural Development & Ministry of Panchayati Raj was held on 23.03.2023 under the Chairmanship of Hon'ble Minister of Rural Development and Panchayati Raj. The agenda of the meeting was - "Watershed Development Component-Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY) 1.0 & 2.0". Members of the Committee actively participated in the meeting.

2. National Conference on Digitizing and Geo-referencing India with Bhu-Aadhaar (Bhumi Samvaad IV) was held in Vigyan Bhawan, New Delhi on 17th March, 2023. The Conference was chaired by the Hon'ble Minister of Rural Development and Panchayati Raj. Minister of State of Rural Development and Steel and Minister of State of Panchayati Raj were present in the meeting. Theme of the meeting included: Democratization of land records data and Matribhoomi, Application of Bhu-Aadhaar in EoDB and Ease of Living and National and global best practices on Geo-referencing, Survey, Resurvey/Bhu-Aadhaar. Various stakeholders including Senior officers of Central Ministries/Departments and State/UT Governments, Members of Academia and Research institutes, Members from business community and civil society facilitated exchange of knowledge and ideas, showcased innovations and shared successful case studies.

3. A meeting of the Core Technical Advisory Group(CTAG) to examine the proposal for establishment of a Project Monitoring Unit (PMU) under DILRMP at DoLR level and revision of rates of manpower in PMU was held under the chairmanship of Secretary (LR) on 13.03.2023.

4. A presentation on Bhu-Aadhaar was made by Joint Secretary(LR) on 24.03.2023 through VC in a conference/meeting organized by DBT Mission, Cabinet Secretariat on Implementation of DBT through Aadhaar ecosystem: online eligibility verification mechanism.

5. Joint Secretary (LR) held a meeting with District Magistrate, South East, Delhi regarding implementation of NGDRS in NCT Delhi on 27.03.2023.

6. A presentation on DILRMP and Bhu-Aadhar was made by Director(LR) through VC in the workshop of the ILDC Workshop series on topic 'Land Administration Innovation through Technology and Structural Reform – Policy and Practice Implications and Impact' organized by Flame University, Pune on 28.03.2023.

7. The 4th Steering Committee of WDC-PMSKY was held under the chairmanship of Secretary, DoLR on 27.03.2023 for approval of additional projects under WDC-PMKSY 2.0.

8. In the context of "International Women's Day", the Department organized a lecture session on "Cancer Awareness Programme with focus on early screening of breast cancer", involving

all women employees of the Department. Dr. Anita Khokhar, Director Professor, Community Medicine, Safdarjung Hospital made the key note address.

9. Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 6376 projects have been completed till date out of the total 6382 {8214 (Sanctioned) - 1832 (Transferred to State)}. End line evaluation of 5672 projects has been received till now.

10. The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows: -

- i. Computerization of Land Records of 6,22,125 Villages completed.
- ii. Computerization of Registration 4,922 SROs completed.
- iii. Digitization of 1,27,38,500 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of Revenue and Registration 4,071 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 3,291 Tehsils completed.
