Monthly summary of important activities of Department of Land Resources during February, 2023.

Unique Land Parcel Identification Number (ULPIN) has so far been adopted in 26 States/UTs viz. Andhra Pradesh, Jharkhand, Goa, Bihar, Odisha, Sikkim, Gujarat, Maharashtra, Rajasthan, Haryana, Tripura, Chhattisgarh, Jammu & Kashmir, Assam ,Madhya Pradesh, Nagaland, Mizoram, Tamil Nadu, Punjab, Dadara & Nagar Haveli and Daman & Diu, Himachal Pradesh, West Bengal, Uttar Pradesh, Uttarakhand, Kerala and Ladakh . Pilot testing of Unique Land Parcel Identification Number (ULPIN) or Bhu-Aadhar has been completed in UT of Chandigarh on 28.2.2023. Pilot testing of ULPIN is being undertaken in 7 more States /UTs- Karnataka, Puducherry, Andaman & Nicobar, Manipur, NCT of Delhi, Telangana and Chandigarh.

- 2. National Generic Document Registration System (NGDRS) has so far been adopted in 17 States/UTs viz. Punjab, Andaman & Nicobar, Manipur, Goa, Jharkhand, Mizoram, Himachal Pradesh, Maharashtra, Dadar and Nagar Haveli, Jammu and Kashmir, Chhattisgarh, Tripura, Ladakh, Bihar, Assam, Meghalaya and Uttarakhand. 11 more States / UTs namely; Madhya Pradesh, NCT of Delhi, West Bengal, Andhra Pradesh, Gujarat, Haryana, Tamil Nadu, Uttar Pradesh, Chandigarh, Odisha and Sikkim have started sharing data with national portal of NGDRS through User Interface / API. Sikkim has recently started sharing registration related data with national portal of National Generic Document Registration System (NGDRS) www.ngdrs.gov.in. Thus, the total number of States/UTs onboarded under NGDRS is now 28.
- 3. Department of Land Resources has notified Ministry of Defence as "appropriate Government" for acquisition of 1482 acres of land at Langateng GC (Gamrala Field Firing Range, Kameng Sector, Tawang District, Arunachal Pradesh) under the RFCTLARR Act, 2013 (No. 13 of 2013) by invoking urgency clause under Section 40 under the provisions of RFCTLARR Act, 2013. The Department has also notified Ministry of Defence as "appropriate Government" for acquisition of 537 acres of land at Bame Village, Basar Circle, Leparada District, Arunachal Pradesh, for the construction of infrastructure for Corps Ammunition Point under the RFCTLARR Act, 2013 (No. 13 of 2013) by invoking urgency clause under Section 40 under the provisions of RFCTLARR Act, 2013.
- 4. The Parliamentary Standing Committee on Rural Development and PanchayatiRaj took the oral evidence of the representatives of the Department on 09.02.2023 with regard to the examination of the Demand for Grants (2023-24) of the Department of Land Resources, Ministry of Rural Development.
- 5. The first meeting of National Level Steering Committee on REWARD scheme took place in India Habitat Centre, New Delhi under the chairmanship of Secretary(LR) on 20.02.2023 to review the progress of the scheme. Representatives from States of Karnataka and Odisha attended the meeting and presented their inputs and suggestions.
- 6. Secretary, DoLR reviewed the progress of Amlaha Cactus project with Dr Shiv Agrawal, Country Representative, International Center for Agricultural Research in the Dry Areas (ICARDA) on 15.02.2023. Joint Secretary (Watershed Management), Department of Land Resources visited Amlaha, Bhopal, Madhya Pradesh on 24.02.23 for reviewing the progress of implementation of WDC-PMKSY 2.0 scheme. He reviewed progress of projects and requested State Government officials to expedite the pace of activities so that they could claim next tranche of installment in the current financial year.

- 7. Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 6376 projects have been completed till date out of the total 6382 {8214 (Sanctioned) 1832 (Transferred to State)}. End line evaluation of 5672 projects has been received till now.
- 8. The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows:
 - i. Computerization of Land Records of 6, 22,116 Villages completed.

ii. Computerization of Registration 4,917 SROs completed.

iii. Digitization of 1,27,38,500 Cadastral Maps/FMBs/Tippans completed.

iv. Integration of Revenue and Registration 4,043 SROs with land records completed.

v. Establishment of Modern Records Rooms in 3,187 Tehsils completed.
