Monthly Summary of important activities of Department of Land Resources during September, 2023

1. The meeting of **Hindi Advisory Committee of Ministry of Rural Development** was held under the chairmanship of Hon'ble Minister of Rural Development & Panchayati Raj at Constitution Club, New Delhi on 12.09.2023. The Committee reviewed the progressive use of Official Language Hindi in the Department of Land Resources and Department of Rural Development.

2. A meeting of the **Project Sanctioning and Monitoring Committee (PS&MC)** under the Digital India Land Records Modernization Programme (DILRMP) was held with States/UTs under the chairmanship of Secretary, DoLR on 21.09.2023. Proposals of more than Rs.1200 crores from 19 States/UTs in 10 components/activities under DILRMP were considered in the said meeting. Chairman PSMC sanctioned various proposals of North Eastern States like Nagaland, Manipur, Tripura, Assam, Sikkim under Digital India Land Records Modernization Programme (DILRMP). Projects related to computerization and digitization of land records under DILRMP for Bodoland Territorial Council of Rs.400 lakhs were approved with the objective to support the North Eastern States.

Department is making efforts to ensure saturation of scheme components under Computerization and Digitization of Land Records under DILRMP. A total number of 157 Districts have achieved saturation of digitization of land records which was 68 Districts earlier in month of August 2023.

3. The Department has observed 'Hindi Pakhwada' during 14th to 28th September, 2023 for promotion of Hindi as official language. Various competitions/ events were organized during the period in which large number of officers/ officials of the Department participated. Officers of the Department participated in the 'Third All India Official Language Conference' organised by Department of Official Language at Pune on 14th -15th September, 2023. The Department organized a Workshop on memory based Hindi translation tool 'Kanthastha 2.0' on 29.09.2023 for the employees of the Department.

4. As part of the media campaign of the Department and with focus on G-20 meeting, the Department installed two '**Selfie Booths**' on Watershed Development with the theme '*Turning barrens into Greens*' and *Bhu-Aadhaar/ ULPIN* under DILRMP at Central Secretariat and Kashmere Gate metro stations respectively, on 07.09.2023 to create awareness about programmes and schemes of the Department. Hon'ble Minister(RD&PR) visited these selfie points on 11th September,2023 through metro ride and interacted with commuters and also took selfies with people. Senior officers of the Department were present during the visit.

5. A review meeting on the progress of **WDC-PMKSY** in Rajasthan, Kerala, Kolkata, Punjab and Haryana was held on 01.09.2023 under the chairmanship of Secretary(LR). Further, two review meetings on 06.09.2023 and 13.09.2023 under WDC-PMKSY 2.0 were held by the Department with the CEOs of concerned

States/UTs through VC on aspects like expenditure, Management Information Systems (MIS), Amrit Sarovar and other issues on WDC-PMKSY.

6. The **Special Campaign 3.0** on Swachhata activities and Disposal of pending references, is being undertaken by the Department in all its three offices i.e. NBO Building, CGO Complex and Shivaji Stadium Annexe. As part of preparatory phase, identification of pending references, cleanliness activities, redundant materials and files for review have been undertaken from 15th September, 2023 to 30th September, 2023 and targets have been set. Obsolete and unusable/ condemned items, e-waste and furniture are being identified through inventory management and process for their disposal through e-auction has been initiated.

7. The Department organised two **Yoga sessions** through renowned Experts on 22nd and 29th September, 2023 at REJUVE wellness centre at Shivaji Stadium Office premise for the employees of the Department.

8. Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 6376 projects have been completed till date out of the total 6382 projects {8214 (Sanctioned) - 1832 (Transferred to State)}. End line evaluation of 6120 projects has been completed till now.

9. The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows:-

- i. Computerization of Land Records of 6,22,834 Villages completed.
- ii. Computerization of Registration 5,037 SROs completed.
- iii. Digitization of 1,31,06,063 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of 4,560 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 3,339 Tehsils completed.
