Monthly Summary of principal activities and important decisions taken by the Department during January, 2019

1. 8214 watershed development projects were sanctioned during 2009-10 to 2014-15 in 28 States (except Goa) under Integrated Watershed Management Programme and later amalgamated under WDC-PMKSY. Under the scheme 30 projects have been reported completed during the month totaling it to 1763 projects upto 31.01.2019.

2. An amount of Rs.1065.32 crores was released to the States upto January, 2019 for watershed development under WDC-PMKSY including Neeranchal.

3. Senior Officers meeting was held under the Chairpersonship of Special Secretary, DoLR ON 16.01.2019 to review WDC-PMKSY and Neeranchal.

4. Two Video Conferences to review implementation of WDC-PMKSY in the States were held on 21<sup>st</sup> January and 24<sup>th</sup> January, 2019.

5. A review meeting on PMKSY including Watershed Development component was attended by Secretary o 21.01.2019 in PMO under the Chairmanship of Principal Secretary to Prime Minister.

6. Measures related to 'Registering Properties' under Ease of Doing Business were reviewed at the level of Secretary in coordination with implementing agencies.

7. Rs.22.47 crores have been released to the States upto January, 2019 during this financial year under Digital India Land Record Modernization Programme (DILRMP).

8. The draft "The Andhra Pradesh (Andhra Area) Inams (Abolition and Conversion into Ryotwari) (Amendment) Ordinance, 2018" and the draft "The Uttar Pradesh Revenue Code (Amendment) Bill, 2018" were examined and departmental views were sent to MHA.

9. Meetings with State Governments / stake holders through video conference are being held under the initiatives during the month under 'Minimum Government, Maximum Governance'.
