Monthly summary of important activities of Department of Land Resources during July, 2023.

1. Department of Land Resources organized the "*Bhoomi Samman 2023*" Event at Vigyan Bhawan on 18<sup>th</sup> July, 2023 in the gracious presence of Hon'ble President of India who conferred the "Bhoomi Samman" to 9 State Secretaries and 68 District Collectors along with their teams who excelled in achieving saturation of the core components of Digital India Land Records Modernization Programme (DILRMP) – the core of Governance. This Event was extremely significant for Revenue and Registration functionaries of the State who received the "Bhoomi Samman" for the first time in the last 75 years for their outstanding performance from Hon'ble President of India. Thus in fact, this was a landmark year for institutionalizing the "Bhoomi Samman".

2. It is to state that Hon'ble Prime Minister had envisioned in the Post-Budget Webinar on 23<sup>rd</sup> February, 2022 that all public welfare schemes should saturate the scheme components with the objective that no citizen is left behind. In a meeting of the Council of Ministers on 3<sup>rd</sup> July 2023, Hon'ble Prime Minister had reiterated the imminent need for saturation of scheme components. As a step in this direction, this Department had initiated performance based grading in six core components of DILRMP. Grading had been done on the basis of performance of Districts as reflected in Management Information System(MIS) of DILRMP and as reported by the State/UT Governments. Platinum Grading Certificates were presented to the Districts which have completed saturation i.e. 100% targets in the respective core components of DILRMP.

3. The Second Workshop on **Preparatory meeting to the Third National Conference of Chief Secretaries** on '*Promoting Ease of Living*' was held on 15<sup>th</sup> July, 2023 under the Co-chairmanship of Secretary, DoLR and Secretary, Ministry of Housing & Urban Affairs. Joint Secretary (Land Regulation), DoLR moderated *two sessions on Land, Property and Mutation* in the Conference.

4. As National part of Generic Document Registration System (NGDRS), Telangana State started sharing the registration related information with National portal of NGDRS through User Interface (UI) from July. As on 31st July, 2023, NGDRS has been rolled out in 17 States/UTs; while 13 States/UTs have started sharing data with National portal of NGDRS through User Interface/API. Thus, a total of 30 States / UTs are covered under NGDRS- eRegistation System.

5. A VC meeting was held by Joint Secretary (Watershed Management) with SLNA, Rajasthan and other stakeholders on 12<sup>th</sup> July, 2023 to discuss the plan of proposed **Cactus Plantation for Production of Bio-gas** from Cactus bio-mass at Hingonia, Goshala, Jaipur, Rajasthan. A meeting on hybrid mode was held on

14<sup>th</sup> July, 2023 under the chairmanship of JS(WM) to discuss on carbon sequestration, carbon credits and how farmers can benefit from carbon credits. Officials from Ministry of Environment, Forest and Climate Change, Bureau of Energy Efficiency, Isha Foundation, Coimbatore, participated in the meeting.

6. Department of Land Resources organized **Yoga sessions** on 21<sup>st</sup> and 28<sup>th</sup> July, 2023 at 'REJUVE wellness centre' at Shivaji Stadium Office premises in which officers of the Department participated. Further, Yoga sessions are being now organized on 2<sup>nd</sup> and 4<sup>th</sup> Friday (afternoon) of every month as part of regular activity through Yoga experts.

7. Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 6376 projects have been completed till date out of the total 6382 projects {8214 (Sanctioned) - 1832 (Transferred to State)}. End line evaluation of 5942 projects has been completed till now.

8. The current status of progress (cumulative) of the different components of **Digital India Land Records Modernization Programme (DILRMP)** is as follows:-

- i. Computerization of Land Records of 6,22,672 Villages completed.
- ii. Computerization of Registration 4,963 SROs completed.
- iii. Digitization of 1,30,65,074 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of 4,288 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 3,326 Tehsils completed.
