# Monthly summary of important activities of Department of Land Resources during June, 2023.

- Unique Land Parcel Identification Number (ULPIN)- BhuAadhaar has been rolled out in 27 States which includes UT of Chandigarh as the recent roll out. States/UTs covered include: Andhra Pradesh, Jharkhand, Goa, Bihar, Odisha, Sikkim, Gujarat, Maharashtra, Rajasthan, Haryana, Tripura, Chhattisgarh, Jammu & Kashmir, Assam, Madhya Pradesh, Nagaland, Mizoram, Tamil Nadu, Punjab, Dadara & Nagar Haveli and Daman & Diu, Himachal Pradesh, West Bengal, Uttar Pradesh, Uttarakhand, Kerala and Ladakh.
- 2. Secretary (DoLR) held a meeting on 06.06.2023 to discuss Memorandum of understanding (MoU) between Department of Land Resources, Ministry of Petroleum and Natural Gas and other stakeholders for promotion of spineless cactus cultivation and its economic usages especially for production of bio-gas under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY) scheme of the Department.
- 3. Secretary (DoLR) and Joint Secretary(Land Regulation) attended the workshop on "Land & Property" sub-theme of Third National Conference of Chief Secretaries (NCCS) organized by Ministry of Housing and Urban Affairs in New Delhi. Joint Secretary (LR) made a detailed presentation on Digital India Land Records Modernization Programme (DILRMP) in context of Ease of Living.
- 4. Joint Secretary (LR) participated in the first Global DPI Summit along with Global Digital Public Infrastructure (DPI) Exhibition held on 12-13th June 2023 in Pune. The purpose of the Summit was to facilitate sharing of experiences and best practices on implementing DPIs and to explore Global DPI repositories for the benefit of global community.
- 5. Joint Secretary (Watershed Management) held two review meetings on World Bank assisted REWARD project with World Bank on 12.06.2023 and 21.06.2023. A separate meeting was held on REWARD project on 27.06.2023 with NRAA and its partner agencies. Joint Secretary (WM) held three meetings on 13.06.2023, 22.06.2023 and 28.06.2023 through Video Conference with the States to review expenditure, MIS implementation and Amrit Sarovar Progress under WDC-PMKSY Scheme.
- 6. The Department celebrated 9<sup>th</sup> International Day of Yoga (IDY)-2023 on 21.06.2023 at Rejuve Wellness Centre of the Department at Shivaji Stadium Office premise wherein Secretary (DoLR) along with other Senior Officers participated in the Yoga Session. Yoga Sessions are also being organized on 2<sup>nd</sup> and 4<sup>th</sup> Friday of every month as part of regular activity by the Department through Yoga Experts.
- Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 6376 projects have been completed till date (99.90% of Projects completed) out of the total 6382 projects {8214 (Sanctioned) - 1832 (Transferred to State)}. End line evaluation of 5841 projects has been completed till now.
- 8. The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows:
  - i. Computerization of Land Records of 6,22,653 Villages completed.
  - ii. Computerization of Registration 4,924 SROs completed.
  - iii. Digitization of 1,28,83,851 Cadastral Maps/FMBs/Tippans completed.
  - iv. Integration of 4,081 SROs with land records completed.
  - v. Establishment of Modern Records Rooms in 3,326 Tehsils completed.
