Monthly summary of important activities of Department of Land Resources during June, 2021

Hon'ble MoRD reviewed the Digital India Land Records Modernization Programme (DILRMP) scheme of Department on 28.06.2021.

In compliance of the Action Plan of DoLR for celebrating Azadi Ka Amrut Mahotsav, online conference/workshop with stakeholders of Registering Property Indicator of Ease of Doing Business were conducted by the Govt. of NCT of Delhi and Revenue Department, Govt. of Maharashtra on 19th June, 2021 and 24th June, 2021 respectively.

The Unique Land Parcel Identification Number (ULPIN) was launched in Chhattisgarh on 23.6.2021 through Virtual Mode by Secretary, Revenue and Disaster Management Department, Govt. of Chhattisgarh in the presence of Secretary (LR).

A meeting of the Committee on linking of e-Court with land records and registration data base was held on 9th June, 2021 under the Chairmanship of Additional Secretary (LR) through Video Conference to deliberate on the issue and finalize the report of the Committee on linking of e-Court with land records and registration data base.

Additional Secretary (LR) took meetings with (i) Settlement Commissioner, (ii) Principal Secretary (Revenue) and iii) Secretary (Panchayati Raj), Government of Rajasthan on 21st June, 2021 at Jaipur to review progress of DILRMP, ULPIN, registration process with reference to NGDRS, status of SWAMITVA, linking of civil court (e-Court) with land records and registration in the State of Rajasthan.

Secretary(LR) held a meeting on 10.06.2021 through VC with World Bank officials to review REWARD appraisal preparedness of the Department. Further, an another meeting held on 11.06.2021 under the Chairmanship of Secretary (LR) with World Bank and partner States, the preparedness of REWARD Projects was reviewed.

Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 4843 projects have been completed till date out of the totat 6382 {8214 (sanctioned) - 1832 (transferred to States)}. End-line evaluation of 2940 project has been completed till now.

The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows: -

- i Computerization of Land Records of 6,00,689 Villages completed.
- ii. Computerization of Registration 4,867 SROs completed.
- iii. Digitization of 1,10,06,455 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of 3,971 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 2,304 Tehsils completed.
