

Monthly summary of important activities of Department of Land Resources during September, 2021

The Hon'ble Minister of Rural Development *inter-alia* reviewed the implementation of the schemes of Department of Land Resources on 15.09.2021 with the officials of Govt. of Uttar Pradesh and on 21.09.2021 with the officials of Govt. of Karnataka respectively during his visits to the two States.

The Hon'ble Minister of State for Rural Development *inter-alia* reviewed the implementation of Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY) scheme of Department of Land Resources in Manipur during her visit to NER States from 26th to 28th September, 2021.

Secretary (LR) held meetings on 03.09.2021 at Pune to review the progress of the implementation of National Generic Document Registration System (NGDRS) with NIC Team, SDU Pune as well as development of software for multilingual land records with C-DAC Team Pune. The progress of the overall land records and registration system was also reviewed with the Settlement Commissioner and IGR based in Pune.

Secretary also reviewed the progress of Ease of Doing Business in Mumbai with reference to Registering Property indicator of Doing Business Report (DBR) In the meeting held with the stakeholders in Pune on 3.9.2021.

Secretary (LR) Chaired a VC on 09.09.2021 on 'Yuktdhara' for GIS planning of projects under PMKSY-WDC 2.0.

The Department held Video Conferences on 14.09.2021 and on 29.09.2021 to review the progress of implementation of PFMS in all States/UTs w.r.t DILRMP and to review the implementation of PFMS in 10 States w.r.t. WDC-PMKSY.

Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 5138 projects have been completed till date, out of the total 6382 {8214 (sanctioned) - 1832 (transferred to States)}. End line evaluation of 3783 projects has been completed till now.

The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows: -

- i. Computerization of Land Records of 6,00,811 Villages completed.
- ii. Computerization of Registration 4,883 SROs completed.
- iii. Digitization of 11,092,333 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of 3,971 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 2,508 Tehsils completed.
