

**Monthly Summary of important activities of Department of Land Resources during September, 2022**

The Department organised a meeting with States/UTs on 09.09.2022 through Video Conference for reviewing the progress of activities under WDC-PMKSY 2.0.

2. National Generic Document Registration System (NGDRS) has been rolled out in Uttarakhand w.e.f. 01.09.2022.
3. As part of preparatory phase of Special Campaign 2.0, various activities were taken up during September 5-20, 2022. The activities included: Identification, review and disposal of pending references, physical files & e-files, electronic items and equipments and strengthening cleanliness drives in all its offices. Necessary coordination was undertaken with Department of Administrative Reforms and Public Grievances through various VC meetings. Review meetings were taken at the Secretary level for successful implementation of Special campaign 2.0. Data have been uploaded on the SCDPM Portal of DARPG on regular basis.
4. Rejuve Wellness Centre of DOLR in Shivaji Stadium Annexe Office was recognised as a special achievement of Special campaign 1.0 in the Good Governance Week (GGW) in 2021. As a model initiative, the activities of Rejuve Wellness Centre were filmed by DD News team on 16.09.2022 for documentation in Special Campaign 2.0. The Department organised two sessions on Stress Management on 20<sup>th</sup> and 21<sup>st</sup> September, 2022 at Rejuve Wellness Centre for its employees.
5. Joint Secretary, Watershed Management, visited Chennai on 04.09.2022 and reviewed the progress of implementation of WDC-PMKSY 2.0.
6. Joint Secretary, Land Regulations reviewed the progress of implementation of DILRMP in UT of Jammu & Kashmir from 21.09.2022 to 24.09.2022. As part of field visit, he visited Srinagar and Ganderbal districts in the UT.
7. Economic Adviser, DOLR participated in National level Rajbhasha meeting held at Surat on 14<sup>th</sup> September 2022.
8. Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 6161 projects have been completed till date out of the total 6382 projects {8214 (Sanctioned) - 1832 (Transferred to State)}. End line evaluation of 5495 projects has been completed till now.

9. The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows:-

- i. Computerization of Land Records of 6,19,154 Villages completed.
- ii. Computerization of Registration 4,893 SROs completed.
- iii. Digitization of 1,17,30,565 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of 4,021 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 2,803 Tehsils completed.
