2. The Steering Committee will perform the functions given below:

- (i) Act as an effective coordinating mechanism involving various Ministries / Departments / Institutions of Central and State Governments for efficient and effective implementation of WDC-PMKSY projects in convergence with the relevant schemes of Centre and State.
- (ii) Undertake policy initiatives for the overall development of rainfed areas.
- (iii) Comprehensive monitoring and review of projects under WDC-PMKSY.
- (iv) Review of policy guidelines for implementation of WDC-PMKSY.
- (v) Adoption of new and established technologies, best practices and innovations in the development of watershed areas.
- (vi) Appraisal / sanction of new projects / foreclosure of projects whenever required.
- (vii) Any other function assigned by the Department of Land Resources.
