**Sub.: Allocation of minimum tentative targets under IWMP for the year 2013-14-reg.**

Sir,


This is to inform that initial tentative targets for new projects under Integrated Watershed Management Programme (IWMP) during 2013-14 have been approved by the competent authority. The list of State wise targets is enclosed.

2. The Preliminary Project Reports (PPRs) for the projects to be proposed during the year 2013-14, after approval of the SLNA, may be furnished to this Department at the earliest for appraisal before the Steering Committee of the Department of Land Resources. The other procedures and guidelines on IWMP issued by the Department from time to time may be complied with.

3. The above allocation will remain valid till 31<sup>st</sup> July, 2013 and thereafter the proposals received from the States will be considered on "first come-first serve basis" Hence, it is requested to ensure that the proposal from the State, complete in all respects, reach the Department of Land Resources well in time .

4. It is also informed that before coming for appraisal of PPRs before the Steering Committee, the data entry both physical and financial in MIS is updated. The review of MIS entry will be done online and progress observed up to one week before the meeting will be presented by NIC Unit of DoLR for review during the Steering Committee meetings scheduled for projects proposed for 2013-14. Hence, it requested to update the data entry in MIS to reflect disbursement of funds up to Watershed Committee (WC) and to reflect expenditure at all levels, atleast to the level of latest Utilisation Certificate.
