Monthly Summary of principal activities and important decisions taken by the Department of Land Resources during December, 2020.

National Generic Document Registration System (NGDRS), a technological initiative of the Department of Land Resources to address the diversity prevailing across the States on account of languages, processes, formulae and formats in the process of registration - won the Digital India Award (DIA), 2020 organized by Ministry of Electronics, Information and Technology in excellence in Digital Governance Category. The award was given by the Hon'ble President of India in a virtual ceremony on 30.12.2020.

A Meeting with the stakeholders of Delhi to review action taken on parameters/reforms and Action Plan to improve ranking in Registering Property indicator of Ease of Doing Business was held on 21.12.2020 under the chairmanship of Secretary(LR) and position in respect of Bengaluru and Kolkata was reviewed by Secretary(LR) on 22.12.2020 through video conferencing.

A meeting under the chairmanship of Secretary (LR) with the States of Andhra Pradesh, Madhya Pradesh, Maharashtra, Telangana, Uttar Pradesh, Jharkhand and West Bengal on pending assurance of Lok Sabha Unstarred Question No.3621 on "Land Banks" and Rajya Sabha Unstarred Question No 1350 on "Acquisition of Land for Industrial Projects" was held on 2nd December, 2020, wherein all these States have been requested to furnish the reply by 10.12.2020.

A meeting of the Core Technical Advisory Group (CTAG) under Digital India Land Records Modernization Programme (DILRMP) was held on 21-12-2020 at 4:30 P.M. through Video Conferencing under the Chairmanship of Secretary, Department of Land Resources, Ministry of Rural Development to revise the existing cost rates of various components of DILRMP on account of factors viz. inflation, request proposals received from various States etc. The meeting was attended by members (technical partners /advisors of / to the Department) of CTAG such as Survey of India, MeitY, NRSC, Forest Survey of India, NIC and Secretary (Revenue) of various States / UTs.

A meeting of the Committee on linking of e-Court with land records and registration data base was held on 4th December 2020 under the chairmanship of Additional Secretary, Department of Land Resources through VC to discuss feasibility of linking of e-Court with land records and registration data base.

The progress of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows:-

- i. Computerization of Land Records of 598149 Villages completed.
- ii. Computerization of Registration 4784 SROs completed.
- iii. Digitization of 10762382 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of 3847 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 2145 Tehsils completed.

Secretary, DoLR and Senior Additional Commissioner (WM) visited Rajasthan from 17-18 December, 2020 to review implementation of WDC-PMKSY and a field visit was made to Watershed projects at Piplantari, Rajsamand district.

Additional Secretary(LR) and Joint Secretary(WM) visited Assam from 6.12.2020 to 8.12.2020 to review implementation of WDC-PMKSY with Senior Officers of State and a field visit was made to Watersheds Project at Nagaon District, Panch Bandar, Hira Basti and Nandapur village.

Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 4716 projects have been completed till date, out of the total 6382 {8214 (sanctioned) - 1832 (transferred to States)}. Rs.160.62 crore against the Revised Allocation of Rs.1000 crore, has been released in December, 2020.
