

**Monthly Summary of principal activities and important decisions taken by the Department of Land Resources during September, 2020**

Ministry of Defence on 8.9.2020 was notified "appropriate Government" in three cases under sub-clause (v) of clause (e) of Section 3 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013) for acquisition of land in Arunachal Pradesh.

Department of Land Resources organised a Video Conference on 22.9.2020 with the State Revenue Officers of the rank of Additional Chief Secretary/Principal Secretary/Secretary/Inspector General of Registration (IGR) under the Chairmanship of Secretary (Land Resources) to review the progress of State/UT Governments under Digital India Land Records Modernization Programme (DILRMP). The issue of preparedness of States to roll out Unique Land Parcel Identification Number (ULPIN) specifically in Bihar, Haryana, Maharashtra, Gujarat, Odisha and Jharkhand and implementation of National Generic Document Registration System (NGDRS) were also discussed in the meeting. After deliberations, four more States: Karnataka, Tamil Nadu, Tripura and Sikkim were also identified for pilot testing of ULPIN.

The progress of the different components of DILRMP as updated on MIS is as follows:

- i. Computerization of Land Records of 591,557 Villages completed.
- ii. Computerization of Registration of 4736 SROs completed.
- iii. Digitization of 8,358,040 Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of 3677 SROs with land records completed.
- v. Establishment of Modern Records Rooms in 1,965 Tehsils completed.

A meeting with the members of the Committee on Land Leasing under the chairmanship of Secretary (Land Resources) was held on 24.09.2020 to suggest the way forward on land leasing in order to facilitate extension of benefits of Central Government Schemes to the actual tillers/ cultivators on one hand and to protect the interest of land owners on the other. The Meeting was attended by the Addl. Chief Secretary/Principal Secretary/ Secretary Revenue of the States of Rajasthan, Uttar Pradesh, Andhra Pradesh, Madhya Pradesh, Maharashtra, Tripura and representatives from DoACFW. Members of the Committee were requested to provide information on their experience/implementation status of Acts/Bills in their State; challenges and methods to overcome those challenges on land leasing along with specific views on the presentation.

A Video Conference to review implementation of WDC-PMKSY in the States of Andhra Pradesh, Assam, Gujarat, Himachal Pradesh, Jammu & Kashmir, Jharkhand, Kerala, Madhya Pradesh, Maharashtra, Rajasthan and Telangana was held on 25.09.2020 under the Chairmanship of Secretary (Land Resources). The Chairmen/Chief Executive Officers/Officials of States participated in the Video Conference.



The Department organized a one-day orientation training programme via Video Conference on 25.9.2020 for officers/staffs of State Level Nodal Agency (SLNA), Rajasthan for proper interpretation of parameters and regular updation of MIS related to WDC-PMKSY through its NIC Team.

Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 4561 watershed development projects have been completed till date out of the total 6382 {8214 (sanctioned) - 1832 (transferred to States)}. Rs.70.01 crore against the total Budget Allocation of Rs.2000 crore (2020-21) has been released in September, 2020. Under Digital India Land Records Modernization Programme (DILRMP), Rs.25.85 crore against the Budget Allocation of Rs.238.65 crore (2020-21) has been released in September, 2020.
